NOTIFICATION

In exercise of the powers conferred by section ^{1A} 43 of the Sikkim Water Supply and Water Tax Act, 1986 (8 of 1986), the State Government hereby makes the following rules further to amend the Sikkim Water Supply Rules, 1990, namely:-

1. Short title, extent and commencement

- (1) These rules may be called the Sikkim Water Supply (Amendment) Rules, 2014.
- (2) They shall extend to the whole of Sikkim.
- (3) They shall come into force on the 1st Day of December, 2014.

2. In the Sikkim Water Supply Rules, 1990 (hereinafter referred to as the said rules), in rule 11, for the existing sub-rules (1) and (2) the following sub-rules shall be substituted, namely:-

- (1) For every domestic and commercial establishment, the following monthly charges of water shall be levied on non volumetric basis as per the table given below:-


Sl.No.	No. of Tap	Domestic	Commercial
NON VOLUMETRIC			
1	1 - 3 taps	Rs. 90/-	Rs. 180/-
2	4 - 7 taps	Rs. 150/-	Rs. 290/-
3	8 - 12 taps	Rs. 250/-	Rs. 390/-
4	Every tap in excess of 12 taps	Rs. 50/-	Rs. 100/-

- (2) The water supply services shall be rationalized with the gradual introduction of volumetric tariff that will replace the tap based tariff system. The rates of the metered (volumetric) tariff per KL (1000 ltrs.) will be as follows:-

1	First 20 KL	Rs. 5/KL	Rs. 10/KL
2	20 - 40 KL	Rs. 8/KL	Rs. 13/KL

3. In the said rules, for the existing rule 17, the following rules shall be substituted, namely:-

NOTIFICATION

In exercise of the powers conferred by section 26 of the Sikkim Sewerage and Sewage Disposal Act, 1987, the State Government hereby makes the following rules further to amend the Sikkim Sewerage and Sewage Disposal Rules, 1990, namely:-

Short title, extent and commencement


- (1) These rules may be called the Sikkim Sewerage and Sewage Disposal (Amendment) Rules, 2014.
- (2) They shall extend to the whole of Sikkim.
- (3) They shall come into force on the 1st Day of December, 2014.

2. In the Sikkim Sewerage and Sewage Disposal Rules, 1990, for the existing rule 10, the following rules shall be substituted, namely:-

"10-1. For every domestic and commercial establishment, the monthly charges of Sewerage Service shall be levied till the rationalization on volumetric basis as per the table given below:-

Sl.No.	No. of Water closet	Domestic	Commercial
NON VOLUMETRIC:			
1	1 st Water Closet	Rs.35/-	Rs. 35/-
2	Every additional Water Closet	Rs.30/-	Rs. 30/-
3	Public Toilet	Rs. 150/-	Rs170/-

(2) After the rationalization of the Water Supply services with the gradual introduction of volumetric tariff, the water closet based tariff system for sewerage services shall be replaced and the rates for sewerage service on volumetric basis shall be '60% of the Water Supply Bill on volumetric tariff for both Domestic and Commercial Establishment'.
