NOTICE INVITING QUOTATION FOR MONITORING AND EVALUATION SERVICES.

Sealed quotations are hereby invited from reputed firms/organizations having expertise in Monitoring & Evaluation (M&E) of sewerage infrastructure projects or similar schemes for undertaking independent Monitoring & Evaluation of the ongoing/completed works of Geyzing, Mangan and Chungthang Sewerage Schemes sanctioned under the Pollution Abatement scheme by the National River Conservation Directorate (NRCD), Ministry of Jal Shakti, Government of India

1. Scope of work:

The selected agency shall carry out comprehensive Third-Party Quality Monitoring services which will broadly include:

- 1. Physical & Financial Progress Monitoring.
- 2. Independent Quality Monitoring of materials and works.
- 3. Compliance checks with technical specification.
- 4. Environmental and Safety Compliance monitoring.
- 5. Submission of Monthly Monitoring reports, including
 - Progress detail.
 - Photographic documentation with GPS tagging.
 - Observations and Recommendations.
- 6. Laboratory testing for materials (pipes, concrete)
- 7. Water quality test (pre and post water quality testing of nearby water bodies like rivers, drains, etc as per NRCD requirements.
- 8. Final consolidated report at project completion.
- 9. The Third-party Quality monitoring is to be undertaken till the completion and commissioning of the projects.

2. Eligibility Criteria.

The Agencies/Firms must satisfy the following criteria:

- Registered Entity within Sikkim only.
- Experience in Third Party Quality Monitoring of sewerage schemes or any centrally sponsored water supply schemes.
- Minimum average annual financial turnover of Rs 50 Lakhs over the last 3 financial vears.
- Not blacklisted by any government departments. (Self-declaration to be submitted)
- Valid PAN and GST registration.
- Must have qualified technical manpower.
- Proof of qualified personnel must be submitted.

3. Earnest Money Deposit and Tender Fee:

- Rs 100,000/- (Refundable)
- To be submitted as Demand Draft or TDR/FDR
- Quotations without EMD will be rejected.
- EMD will be refunded to unsuccessful bidders after award of the work.
- Non-refundable Tender fee of Rs 5000/- in the form of Bank Receipt paid to SBS under the head: 0215-water supply & sanitation-PHE 01.800-Other Receipts shall be submitted along with the EMD.

4. Bid submission process:

Quotations must be submitted in two separate sealed envelopes:

- Envelope 1: Technical Bid (with all documents and EMD)
- Envelope 2: Financial bid (with price quotations only)

Both envelopes must be placed inside a single sealed cover clearly marked:

"Quotation for TPQM Services under M&E component of Geyzing, Mangan and Chungthang Sewerage Scheme (NRCD Project)."

5. Documents to be submitted with Technical Bid:

- 1. Covering letter on Firm's Letterhead.
- 2. Firm Registration/ Trade License.
- 3. PAN Card and GST registration.
- 4. Audited balance sheet or CA certificate for last three financial years.
- 5. Experience certificate.
- 6. List of key technical personnel with qualification documents.
- 7. Declaration of non-blacklisting (Self Declaration)
- 8. EMD in original (In DD or TDR)

6. Documents to be submitted with Financial Bid:

- 1. Total Lump sum quote (inclusive of taxes, travel, lodging, testing charge, documentation etc)
- 2. 2. Payment terms.
- 3. Quotation validity (minimum 90 days)

7. Evaluation and Selection Process:

Opening of Technical Bids:

All technical bids will be opened on the specified date and evaluated based on eligibility, team qualification and methodology.

Opening of Financial Bids:

Financial Bids of only technically qualified bidders will be opened in the office of the Pr. Chief Engineer, PHED.

Selection Process:

The agency quoting the lowest total cost (L-1) among technically qualified bidders will be selected.
